U.S. State Cybersecurity Law Category Presence Matrix

This matrix provides a high-level view of the U.S. state cybersecurity law landscape by category. It shows where state-level obligations commonly exist across breach notification, unlawful access statutes, privacy duties, and key sector overlays, including insurance, education, health data, and government governance. Two categories are universal across all states: breach notification and computer crime and unlawful access statutes. Other categories vary by state and by sector.

For CPL, this matrix establishes the jurisdictional context in which practitioners and organizations must operate. It supports state selection during CPL registration and informs the jurisdiction profile checklist that guides governance alignment. The objective is clarity and repeatability: a shared view of which legal categories exist in a state, before mapping them to engineering standards and evaluation expectations.
